Welcome to the first 'Safeguarding Newsletter' of the new 2023-2024 academic year at Chivenor Primary School. Here at Chivenor Primary, we take safeguarding very seriously and want to work together with parents, carers and families to help keep all of our Griffins safe, both in and out of school. I am delighted to introduce some new members to our safeguarding team (below) who bring with them a range of skills and experience that will strengthen the team and the provision we can offer to our Griffins and their families. Please remember that if you ever have a safeguarding concern you can speak to ANY member of staff or a member of our school's safeguarding team, details of which are provided below, available from the school office, website and displayed on posters around our school. We do ask that you do not approach children or their parents directly. We also ask you to remember that our Griffins are always at the heart of all decisions made and the door is always open if you need. We look forward to working with you and your children. Mrs Cox

#### What is the role of the DSL at Chivenor?

The Designated Safeguarding Lead has a crucial role in taking lead responsibility for child protection issues in school. At Chivenor, we are lucky to have a safeguarding team of 1 DSL and 4 Deputy DSL's (see table below). A DSL is always available during school hours for staff to discuss any safeguarding concerns. There will always be a member of the safeguarding team on site and the DSL is always contactable by telephone or email outside these hours.

DSL's are trained to take on this role and that training is updated every two years with additional training and conferences in between. The DSL has many responsibilities including working with staff and agencies involved in safeguarding children, working with parents and families, giving advice to staff, training staff, managing referrals from staff and investigating concerns passing them onto the correct agency as necessary, managing the records of safeguarding and Child Protection concerns etc. Please do not be offended if a member of the safeguarding team calls; it is part of their role to speak to parents/carers to ensure our children and their families are safe and getting the support they need.


#### Out of hours Emergency Duty Team: 0121-675-4806

If there is a medical emergency, danger to life or risk of imminent injury, or if a crime is in progress you should call **999** for the appropriate emergency response.

To report crime or anti-social behaviour, to contact your local police station or to get police assistance in a non-emergency dial **101**.

Parents <u>should not</u> email the DSL / Head to report urgent concerns in case the email is not picked up. You can discuss concerns in person with the DSL at Chivenor Primary School or email Mrs Cox / Mrs Guest over the holidays: **safeguarding@chivenor-gst.org**

#### Attendance and Safeguarding

A polite reminder to parents and carers. Please call school on <u>0121 675 9833</u>, if your child is unwell.

It is important you let us know if your child will not be at school, or if you need to collect them for appointments.

If we have not heard from you, we will attempt to **contact the home by phone, email and/or text message.** For Griffins in Y5 and Y6, permission to walk home needs to be given– there is a form to complete in the main office.

#### Keeping Children Safe in Education (KCSiE) 2023

Keeping Children Safe in Education is a statutory Department for Education document which all schools must follow when carrying out their duties to safeguard and promote the welfare of children. It covers many aspects of safeguarding including different forms of abuse, early help processes, safe recruitment, how concerns must be reported and the role of Designated Safeguarding Leads. Safeguarding and promoting the welfare of children is defined as:

\*Protecting children from maltreatment;

\*Preventing impairment of children's mental and physical health or development;

\*Ensuring that children grow up in circumstances consistent with the provision of safe and effective care

\*Taking action to enable all children to have the best outcomes.
